## The Importance of the GSR

Group Service Representatives, also called GSR's form the foundation of our service structure; participating in Area Service Committee meetings, attending workshops, and taking information to and from the Groups they serve.

As stated in NA IP No. 2 The Group, ... in becoming a GSR, responsibilities include:

- Attending the Area Service Committee meetings regularly.
- Serving as a member on Area Service subcommittees.
- Serving as a liaison between the Group and the Area.
- Sharing responsibilities with the GSR Alternate of your Group.
- Keeping the Group Accurately registered with World Service.

The most important facet of this position is to be the communicator for the Group and the rest of the fellowship. The GSR is the vital link of communication whose purpose it is to represent the Group's conscience in matters affecting other Groups or NA as a whole. This duty requires the representative to provide information to the group about developments in the worldwide NJ Fellowship and to share with the Area any activities, strengths, or problems of the group. It is important that the GSR not break the chain of NA communication.

The commitment of the GSR Alternate parallels that of the GSR, except that it is a two-year commitment with the first year spent in training and the second year as GSR. It is imperative that the GSR Alternative attend each Area Service Conference in order to learn and to provide the GSR with support. The GSR Alternate also acts as GSR in the absence of the GSR.\*

A second GSR Assembly is scheduled for the northern Counties of the Region on December 16, 2006, at the Knights of Columbus Hall in Edison from 2:00 to 6:00 PM. Participating in service work is part of working the Twelfth Step. There is nothing more precious than the gift that NA has given each of us and we must remember that this is a WE Fellowship and what WE cannot do alone, WE can do together and we must keep in mind **the importance of the GSR.**

## Updating NA Meeting Information

Many Groups do not know the importance of updating their meeting information on the Regional Website at [nanj.org](http://nanj.org). When you go to the Website and update your information, it is automatically sent to the NJ Statewide Meeting Directory for updating in the next printing of the Statewide Directory. The Directory is printed about twice a year and relies on the information from the Website to keep a current record of meeting locations.

Keeping information current has a four-fold benefit. First, there are addicts who travel around the state and look at the Website for a meeting in the neighborhood that they will be visiting.

Second, the information from the Website is the same information that is printed in the Statewide Meeting Directory.

Third, the same information is passed along to the Helpline to insure that the information will be current when obtained by an addict when calling the helpline.

Fourth, the recently acquired Regional Insurance for all Groups in NJRSC relies on the information in the Statewide Directory to provide a listing to the insurance agent.

So please, if your Group has any facility changes, updates, or deletions, go to the Website at [nanj.org](http://nanj.org) and click on NA MEETINGS in the left column. On the next page, click on **Update it here** in the middle of the page. This will take you to the update form. Please be sure to include your email address because there are often questions that need answering before the updating process can be completed.

I hope this information has helped you understand the importance of **updating NA meeting information**.

- Monitoring the NJ Transit bus poster project.
- Providing an information booth at the Annual Treatment Providers Conference in Atlantic City in April of each year.
